



Health sector

The health sector is a high tech sector and thus plays an important role in technical advancement. Other than data processing and the electronics industry, no other branch of science invests as much worldwide in research and development as the health sector.

The unique characteristics of this sector may already be observed in the planning and construction of healthcare facilities. Highly-equipped technical buildings present stringent requirements for those involved in their planning and construction – from the needs-assessment stage through to commissioning. They must anticipate future developments such as, for example, operation as a “Smart Hospital” and sustainability issues. With funded projects – as it is often the case here – close coordination with the funding body is required and procurement law provisions must be closely observed.
